

STATUTE OF THE HYGIENE-COMMISSION OF THE F. D. I.

Object

The H. C. F. D. I. has resulted from art. 2 sub c. of the Rules and Regulations of the F. D. I.

The committee is permanent, provided that its conclusions are to be subjected to the Executive Council whose decisions are final (see standing orders of the F. D. I.)

The object of the H. C. of the F. D. I. is the propagation of dental hygiene in all countries.

I. By promoting the introduction and perfection of rational dental care in different bodies, schools, sickfunds, etc.

II. By trying to obtain that dental attendance should be considered on the same basis as medical care in cases where social provision has been organised.

III. By founding an international institution for dental hygiene.

IV. By any means the committee may deem proper.

Membership.

The H. C. F. D. I. consists of:

I. Delegated members of the different associations affiliated or members of the F. D. I. who will be admitted afterwards.

II. Persons or groups outside the dental profession, but who are interested in dental Hygiene and willing to assist in attaining the realisation of this object. The persons or groups above mentioned may be admitted by the F. D. I. on proposal of the H. C.

III. Honorary members i. e. persons having rendered valuable services to the cause of hygiene. Same are elected by the F. D. I. on proposal of the H. C. These members are allowed to attend the sessions and will have consultative vote. They are not obliged to pay subscription.

Management.

I. The H. C. shall be managed by its board, appointed for a period of five years by the F. D. I. The members are eligible for re-election. Deceased or resigned members will be replaced at the next session for the time left.

II. The management shall consist of a chairman, two vice-chairmen, a general-secretary a vice-secretary, a treasurer and several permanent reporters.

III. The board shall have a right to appoint permanent sub-committees and sub-committees for a certain period, both for the purpose of studying certain special problems, and submitting a report to the H. C.

The presidents of the permanent sub-committees are the permanent reporters of the board mentioned sub II.

The President and Secretaries of the Committee shall be ex-officio members of all permanent commissions.

IV. The Committees shall be officially represented by the chairman and his deputy.

V. All written acts, engaging the H. C. must be signed by the chairman and the secretary. Besides the signature of the treasurer is required for all financial acts.

VI. The Committee shall submit a annual account of the activities of the H. C. and a financial report.

The Committee of the H. C. is authorized to assemble during the year together with those members of the H. C. who collaborate in matters on hand. The members of the H. C. are invited to attend.

Financial Matters.

The resources comprise:

I. An annual contribution of the F. D. I. the amount to be designated by the Executive Committee according to a proposition of the H. C.

II. All resources and gifts the H. C. may be able to obtain by its own means.

Financial Management.

The funds obtained will be used:

I. For general expenses and re-imburements of the expenses made by those members of the committee who are charged with a special commission when executing same.

II. For carrying out projects approved of by the H. C. The funds on hand must be deposited in a Bank designated by the Committee.

Publication.

The committee appoints a Press-committee charged with the publication of all articles, reports and communications either of its own account or through the intermediary of the dental press.

Sessions.

During the assembly only such subjects may be treated as have been distributed among the members in advance. The members are supposed to be acquainted with their contents. These reports should be sent to the secretary at least three months prior to the date of meeting who shall see to it that the reports be distributed among the members in time before the assembly will be held. At the meeting the summary only will be read and defended by the compiler, after which the theses will be brought into discussion. The compiler or reporter will be allowed half an hour at the utmost for his explanation. The other debaters will have no more than 5 minutes each. Replies will only be allowed once. The meeting has power to allow exceptions.

Dissolution.

In case of dissolution the funds on hand on the day of dissolution shall be allotted to some hygienic dental object, to be designated by the Executive Committee of the F. D. I.
